


Where has the eel industry come from ?

- A long journey over 1000's years of human culture
- 2001 Alarmbells rang on the perilous state of the eel stock
- 2007 after great deliberation EU Regulation 1100/2007 for protection and sustainable use of the stock
- 2008 IUCN lists Eel as Critically Endangered
- ✤ 2009 CITES Listing at Appendix II + EU export ban
- 2007 -2012 Member States develop their Management Plans



A Precautionairy Approach



- Sel a panmictic species
- Sel a catadromic fish
- Eel long living, widely dispersed and mankind is unable to accurately measure the population
- A Common Wild Capture Fishery Methodology can not be applied
- A Common Freshwater Fisheries Methodology can not be applied
- So Eel is so special and unique so specific solutions need developing



CITES and IUCN

A Couple of Key Sentences

CITES Appendix II says: "Appendix II lists species that are not necessarily now threatened with extinction but that may become so unless trade is closely controlled"

 IUCN says: "Well-regulated trade can contribute positively to the conservation of some threatened species, and may be essential for human livelihoods."







- So May 2009 SEG emerges from the Bridgewater Eel Conference
- Meanwhile: in the Netherlands DUPAN emerged, IFEA in Germany other members of the eel industry connect to SEG
- ✤ 2010 first meeting in Hamburg, SEG focusing on the EU
- 2010 Supermarkets Ban the sale of all eel products in in major eel markets of DK, S, D and NL
- 2015 Eel Stewardship Association starts with the Eel Stewardship Funds introduced into NL and D

Sustainable vs. Stewardship

Sustainable the the Brundtlandt definition:

"Sustainable development is development that meets the needs of the present without compromising the ability of future generations to meet their own needs".

- Translations of the words "Sustainable and sustainability" do not fit easily with some other languages
- Renewable or everlasting is also difficult
- These concepts also need Stewardship





- Why ? Polarisation of people and organisations when there are so many similar goals
- Cooperation will enable the protection and recovery of the eel
- To miss quote from a famous line: A small step for mankind but a giant leap for the eel
