### Conditions:

1. All fishers with incorrect nets, purchase and install correct sized nets by 1 December 2023.
2. The fishermen of the Arès canal who store at home to set up a system of traceability of the mortality during storage so that the auditor can verify the mortality during the next audit.
3. New *Attestations de l'Honneur* to be made for all fishers to be certified .
4. To implement a Group Certification procedure by 1 December.
5. An on-site audit to be arranged by 15 December to verify these conditions have been met.
